AN ACT

further to amend the ⁵[Khyber Pakhtunkhwa] Finance Ordinance, 1982.

WHEREAS it is expedient further to amend the ⁶[Khyber Pakhtunkhwa] Province Finance Ordinance, 1982, for the purpose hereinafter appearing;

Preamble.

It is hereby enacted as follows:—

1. (1) This Act may be called the ⁷[Khyber Pakhtunkhwa] Finance (Amendment) Act, 1985.

Short title and commencement.

- (2) It shall come into force at once and shall be deemed to have taken effect on 1st July, 1984.
- 2. In the ⁸[Khyber Pakhtunkhwa] Ordinance No. V of 1982, in subsection (1) of section 4,-
