No. S&GAD/WF/1851-2003/ In exercise of powers conferred by Section 7 of West Pakistan Government Employees Welfare Fund Ordinance, 1969, (W.P Ord. No.1 of 1969), read with Sub-Section (7) of Section 3 thereof, the Government of ²[Khyber Pakhtunkhwa] is please to make the following rules, namely:

THE ³[Khyber Pakhtunkhwa], GOVERNMENT EMPLOYEES WELFARE FUND (GRANT OF FACILITY) RULES, 2005

- 1. (i) These rules may be called ⁴[Khyber Pakhtunkhwa], Government Employees Welfare Fund (Grant of Facility) Rules, 2005.
 - (ii) They shall come in to force at once.

2. **Marriage Grant**

- (i) Every Government Servant regularly contributing to the Welfare Fund shall, twice in his entire service, be entitled to the Grant of Rs.10,000/-(Rupees Ten Thousand Only) from the said Fund, as financial assistance, on the occasion of his own marriage or the marriage of his son or daughter.
- (ii) A Government Servant desirous to avail the grant admissible under Sub-Rule (i) shall apply to the Secretary, Welfare Fund Board through the Head of his Office or Department, or through the Administrative Department concerned, as the case may be, in Form I appended to these rules.

3. **Major Disease Grant**

(i) ⁵Government Servant BPS-01 to BPS-15 regularly contributing to the Welfare Fund shall, from the said Fund, be entitled to receive a sum of Rs.1,000 (Rupees One Thousand Only) Per Month as financial assistance to defray the expenses of his own treatment or treatment of a member of his family; provided that the Government Servant or a member of his family for whom the financial assistance is claimed suffers from a major disease.

- (ii) The financial assistance under Sub-Rule i) shall be in addition to, and not in lieu of, any other financial assistance admissible to him under any other law or rule for the time being in force.
- (iii) A Government Servant shall apply for the financial assistance to the Secretary, Welfare Fund Board, through Head of his office or Department, or through the Administrative Department concerned, as the case may be in Form II appended to theses rules. The application shall be supported by a certificate to the effect that the Government servant or the member of his family for whom the financial assistance is claimed, suffers from a major disease, issued by the doctor Incharge under whose supervision the patient is receiving treatment.

Explanation: For the purpose of this rule major diseases shall mean Cancer, Diabetes, Hepatitis, TB, Thelisimia, AIDS, Heart Disease and Kidneys' Failure.
