Khyber Pakhtunkhwa Advocate-General (Terms and Conditions of Service) Rules, 2005

No.E&A(LD)11-42/90, dated 20-7-2005.--In pursuance of the provisions contained in Article 140 of the Constitution of the Islamic Republic of Pakistan, and in suppersession of the ¹[Khyber Pakhtunkhwa] Advocate-General (Terms and Conditions of Service) Rules, 1977, the Governor of the ²[Khyber Pakhtunkhwa] is pleased to make the following rules, namely:--

Short title and commencement.---(1) These rules may be called 1. the ³[Khyber Pakhtunkhwa] Advocate-General (Terms and Conditions of Service) Rules, 2005.

They shall come into force at once. (2)

2. **Definitions.--**In these rules, unless the context otherwise requires,---

- "Advocate-General" means the Advocate-General for the ⁴[Khyber (a) Pakhtunkhwa] appointed under Article 140 of the Constitution of the Islamic Republic of Pakistan;
- ⁵[Khyber "Government" of (b) means the Government the Pakhtunkhwa];
- "High Court" means the Peshawar High Court; and (c)
- "Supreme Court" means the Supreme Court of Pakistan. (d)

3. **Prohibition of private practice.**---Except as may be allowed by Government, the Advocate-General shall not engage himself in private practice of any kind.

^{4.} Emoluments and fees.---(1) The Advocate-General shall be paid the following remuneration and fees, namely:

^{[(}a) a retainer of Rs. [50,000] /-per month;

for all work before the Supreme Court, a fee at the rate of Rs. [7500]/- per day;] (b)

non-practicing allowance of Rs. [50,000]/- per month;] [(bb)

for all criminal work before the High Court, a fee at the rate of Rs. [600] per case per appearance; (c)

⁽d) for all civil work other than miscellaneous work before the High Court, a fee at the rate of Rs. [1000] per case per appearance:

for writ petition before single bench Rs.300 per case per appearance, and for full bench hearing Rs.500 (e) per case per appearance.

(i) a retainer of Rs. $^{7}[100,000]/$ - per months; and

(ii) non-practicing allowance of Rs. ⁸[500,000] /- per month]

(2) No fee shall be allowed to the Advocate-General for opinion work of Government or for attending any proceeding of the Provincial Assembly of the ⁹[Khyber Pakhtunkhwa].

5. Leave.--The Advocate-General shall be eligible for leave as follows:

- (a) leave on pay equivalent to full pay may be granted up to 1/11th of the period spent on duty as Advocate-General; provided that leave of this kind shall not accumulate beyond four months;
- (b) leave may be granted on medical certificate on pay equivalent to half pay up to 2/11th of the period spent on duty as Advocate-General, subject to a maximum of three months at any one time;
- (c) extraordinary leave may be granted without allowances subject to a maximum of three months at any one time;
- (d) leave of the various kinds may be granted in combination up to a maximum of six months only at any one time;
- (e) for the first two years of the appointment, the Advocate-General will not be entitled to more than one month's leave except on medical certificate in any one year.

6. Accommodation, house rent, etc.---For the purpose of official residence, the Advocate-General shall be deemed to be an officer of the Provincial Government in Basic Pay Scale No.20; provided that where official accommodation is not available, the Advocate-General shall be entitled to house rent allowance at the rate of Rupees ¹⁰[100,000] per month.

7. Telephone facility.--- $^{11}[(1)]$ There shall be no limit of using the telephone for official use by the Advocate-General. However, a facility of two thousand and five hundred local calls per month is permissible for residential use free of charge.

Medical facility .--- The Advocate-General shall be entitled to 8. medical facilities as permissible for $^{13}[\ldots]$ a Provincial Minister.

¹⁴[9. Transport.---- The Advocate General shall be entitled to a ¹⁵[1600]cc staff car for official use with 300 liter POL in accordance with the instructions or rules applicable for the use of staff car and POL.]

Travelling Allowance.--- $^{16}[(1)]$ The Advocate-General shall be 10. entitled to travelling, mileage daily allowances as admissible to officers of Grade-22.
