In exercise of the powers conferred by the section 115 of the ²[Khyber Pakhtunkhwa] Forest Ordinance, 2002, (³[Khyber Pakhtunkhwa] Ord. No XIX of 2002), read with section 58 thereof, and in supersession of all previous rules on the subject, the Governor of the ⁴[Khyber Pakhtunkhwa] is pleased to make the following rules:

- 1. Short title and commencement: -
 - (1) These rules may be called the ⁵[Khyber Pakhtunkhwa] Duty on Forest Produce Rules, 2004.
 - (2) The rules shall come into force at once.
- 2. Definitions: -
 - (1) In these rules, unless the context otherwise requires,
 - (a) "Appendix means the appendix appended to these rules;
 - (b) "Check Post" means any place fixed for checking of timber, firewood or other forest produce and collection of duty, if any, imposed in respect thereto during its transit;
 - (c) "Depot" means any building or place where timber brought and stored for transportation as determined by the Divisional Forest Officer concerned; and
 - (d) "Ordinance" means the ⁶[Khyber Pakhtunkhwa] Forest Ordinance, 2002 (⁷[Khyber Pakhtunkhwa] Ord. No. XIX of 2002).
 - (2) Other words and expression used in these rules, but not defined, shall have the meanings respectively assigned to them under the Ordinance, or any other law for the time being in force.
- 3. Duty on forest produce: -

- (1) There shall be levied a duty in respect of-
 - (a) All timber, fire wood and other forest produce as mentioned in schedule-I to Ordinance or as may be notified by the Government from time to time, if transported from or to any place within the settled District of the North-West Frontier Province, and extracted from forest worked under a regular working plan or extracted from trees marked for felling, tapping and worked under supervision of the Forest Department at the rates mentioned in column 3 of schedule I appended to these rules in accordance with the description specified in column 2 thereof;
 - (b) All timber, firewood and other forest produce as mentioned in schedule- I to Forest Ordinance, 2002 or as may be notified by the Government from time to time if transported in contravention of any rules from or to any place or extracted from trees not worked under a regular working plan or under supervision of the Forest Department, at the rates mentioned in column 4 of the Appendix-I appended to these rules, in accordance with the description specified in column 2 thereof;
 - (c) All timber, firewood and other forest produce other than that specified in clause (a) and (b) above and brought to settled District in the ⁸[Khyber Pakhtunkhwa] from areas not under the administrative jurisdiction of Government or not transported under the authority of the Government, shall be levied at three times the rates mentioned in column 4 of Appendix-I appended to these rules in accordance with the description specified in column 2 thereof,
- (2) Such duty on timber, firewood and other forest produce shall be collected at the time of issuing of the transport pass by the Divisional Forest Officer or the Forest Check Post specified by him:

Provided that such duty on timber, firewood and other forest produce, placed, stored and lying in depots specified in column 3 of Appendix-II appended to these rules shall be collected by Divisional Forest Officer concerned.

- (3) No timber, firewood and other forest produce shall be removed from depots until it is measured or weighed, marked and the duty in respect thereof is paid and a challan to that effect is obtained from the officer appointed by the Divisional Forest Officer, in charge of the Forest Division concerned.
- (4) The timber and other forest produce covered by the permits issued by Political Authorities of the tribal areas and Forest Department of Northern Areas, Azad Jammu & Kashmir and of other provinces shall, for the purpose of duties leviable

under these rules may be treated as if it has been extracted under the control and supervision of the Forest Department.

5. Procedure: -

Where any difficulty is being felt in the smooth functioning of these rules, the Chief Conservator of Forests may issue such instructions and directions, not inconsistent with these rules, as deemed necessary.

6. Revision of Appendix: -Rates specified in Appendix-I may be revised by Government from time to time.
