In exercise of the powers conferred by subsection (2) of section 10 of the Khyber Pakhtunkhwa Youth Affairs Management and Disposal of Immovable Properties Act, 2019 (Khyber Pakhtunkhwa Act No. IX of 2019), the Government of Khyber Pakhtunkhwa is pleased to make the following rules, namely:

THE KHYBER PAKHTUNKHWA JAWAN MARKEZ RULES, 2021.

<u>Part-I</u> <u>Preliminary</u>

- 1. Short title and commencement.—(1) These rules may be called the Khyber Pakhtunkhwa Jawan Markez Rules, 2021.
 - (2) These rules shall come into force at once.
- 2. **Definitions.**—In these rules, the following expressions shall have the meanings as are assigned to them, that is to say,-
 - (a) "Act" means the Khyber Pakhtunkhwa Youth Affairs Management and Disposal of Immovable Properties Act, 2019 (Khyber Pakhtunkhwa Act No. IX of 2019);
 - (b) "Caretaker" means the official of the Department, to be appointed or designated for the purpose of looking after the affairs of Jawan Markez;
 - (c) "Jawan Markez" means the Jawan Markez, established under rule 3 of these rules;
 - (d) "Province" means the Province of Khyber Pakhtunkhwa; and
 - (e) "youth" means youth, as defined in clause (h) of section 2 of the Khyber Pakhtunkhwa Youth Welfare Endowment Fund Act, 2019 (Khyber Pakhtunkhwa Act No. XXVI of 2019).

Part-II

Establishment of Jawan Markez, Membership and its Cancellation

- 3. Establishment of Jawan Markez.— (1) Government may establish such number of Jawan Markez, at the district level, as it deems appropriate, where indoor games are arranged by the Department for the entertainment and recreation of youth and shall provide a platform for engaging and counseling of youth through physical and digital source.
- (2) The Jawan Markez shall be under the administrative control of the Directorate and its management shall be under the control of the Caretaker. The Caretaker shall be assisted by such number of officials or staff members as may be required.
- 4. Registration.--(1) The youth, who intends to take in any one or several activities or games in the Jawan Markez, shall get himself registered by submitting a written application to the Caretaker, specified by the Directorate.
- (2) The youth, while submitting an application, under sub-rule (1), shall also submit an acknowledgement receipt, in respect of deposited fee, as provided under rule 5 of these rules and such other documents as the Directorate may specify from time to time.
- (3) The Caretaker, after receiving an application, complete from all aspects, shall enter its entry in a register maintained by him for the purpose of records.
- 5. Fee.—(1) The Department. for the purpose of registration and membership to the youth in the Jawan Markez, shall specify a reasonable fee, from time to time, which shall be deposited by the Caretaker with the Drawing and Disbursing Officer of the Directorate and the Drawing and Disbursing Officer shall further deposit the same in the designated bank account, maintained in the Bank of Khyber.
- (2) An acknowledgement receipt, with regard to the depositing of fee, shall be issued to the youth, which shall be sufficient for him to get the membership in Jawan Markez.
- (3) For the purpose to keep the registration effective, the youth shall deposit in the Directorate, the specified fee on monthly basis, after getting the membership:

Provided that the youth may be granted fifteen (15) days as grace period after completion of one month, for the purpose of depositing the monthly fee.

- 6. Issuing of card.---(1) The Caretaker, after satisfying himself, shall get the youth registered as member of Jawan Markez and shall issue him a registration card bearing a specific registration number.
- (2) The registration card, so issued under sub-rule (1) shall be valid for a period of one year subject to the payment of monthly fee as specified in rule 5 of these ules.
- (3) A youth, whose card is expired, after a period of one year, may apply afresh, for the purpose of registration for the next year. The procedure, so prescribed for the purpose of first registration under these rules, shall *mutatis mutandis* apply to this surrule.

- 7. Depositing of fee.— (1) The fee. so collected under sub-rule (1) of rule 5, shall be deposited in the designated account of the Fund in the Bank of Khyber on 30th of each month.
- (2) The amount of fee, credited to the specific account, shall be utilized for the welfare, management, maintenance etc; of the Jawan Markez, which also includes the maintenance of equipment and instruments so installed therein.
- 8. Cancellation of registration.—(1) The Directorate may cancel the registration card of a youth, if he fails to deposit the monthly fee after the expiry of grace period, prescribed in sub-rule (3) of rule 5 of these rules.
- (2) Without prejudice to the generality of sub-rule (1) the Directorate may, by its own or on a complaint made by any person against a youth that he is not following the instructions, issued by the Directorate from time to time, and such youth found violating them, or it is proved that he is involved in any immoral activity, cancel the registration card issued to such youth.
- (3) The cancellation of registration card, under sub-rule (2), disentitles the youth to apply for re-registration for a period of one year:

Provided that the youth whose registration card is cancelled due to his involvement in immoral activity, shall not entitle him to get himself registered even after the expiration of one year.

<u>Part-III</u> Miscellaneous

- 9. Time schedule.—(1) The Directorate shall, for the purpose of developing specific timing for male and female youth, issue instructions from time to time. Male shall not be allowed to enter into Jawan Markez, at the time specified for female and similarly female shall not be allowed to join the Jawan Markez at the time specified for male.
- (2) The female youth shall be provided with female staff and other member and male youth shall be severed by male staff.
- (3) The Carctaker shall affix, in conspicuous part of the Jawan Markez, the exact timing of activities, for both male and female youth, which shall strictly be adhered by the youth.
- 10. Security.—(1) The Directorate, for the purpose of security of the Jawan Markez, shall depute such number of security personnel as may be required.
- (2) The security personnel shall be regulated by such instructions as may be issued by the Department or Directorate from time to time or under any relevant law for the time being in force.
- 11. Observance of discipline.—The youth and staff of the Jawan Markez are bound to maintain the discipline inside the Jawan Markez and those who involves in violating the discipline, shall be proceeded against, which may, in case of youth, in addition to cancellation of his membership under sub-rule (2) of rule 8 of these rules, shall also be liable such youth and staff of Jawan Markez for criminal proceedings as well.

- 12. Code of conduct.—(1) The youth, in the Jawan Markez, are required to maintain standard of behavior and such other instructions, as issued by the Department, Directorate or the Caretaker, as the case may be, from time to time.
- (2) The youth are required to carry with him the registration card issued to him by the Caretaker and shall produce the same on demand by the Caretaker.
- (3) The Jawan Markez shall be kept clean and hygiene. Notices shall not be pasted on walls nor the walls shall be scrubbed on.
- (4) The instructions, with regard to timing, issued by the Caretaker, shall be complied by the youth.
- (5) The youth shall cooperate with the Caretaker and other officials of the Jawan Markez.
- (6) The youth shall be responsible for any damage caused to the property in the Jawan Markez and he shall be required to make good the damage.
- (7) Smoking and consumption of alcoholic drinks or narcotics drugs, in the Jawan Markez premises, is strictly prohibited, nor shall the youth be allowed to enter the Jawan Markez premises in intoxicated state.
- (8) The youth shall not be allowed to bring with himself arms and ammunition in the Jawan Markez.
 - (9) The youth shall not be allowed to accompany himself such other outsider:

Provided that such outsider may be allowed with prior permission of the Caretaker.

- 13. Responsibility of personal belonging. —(1) The youth shall be personally responsible for the safe keeping of their personal belonging and shall ensure to keep all valuable items in lock and in case of any theft promptly report to the Caretaker.
- (2) After receiving any information under sub-rule (1), the Caretaker shall forthwith inform the Directorate and the Directorate may proceed to probe the matter in such manner as it may deem appropriate.
