No. So (T&N) 4-12/4/2020: In exercise of the powers conferred by clause (e) of sub-section (2) of section 57 of the Khyber Pakhtunkhwa Control of Narcotic Substances Act, 2019 (Khyber Pakhtunkhwa Act No. XXXI of 2019), the Government of Khyber Pakhtunkhwa is pleased to make the following rules, namely:

THE KHYBER PAKHTUNKHWA NARCOTIC CONTROL WING (REWARD) RULES, 2021.

- 1. Short title and commencement.---(1)These rules may be called the Khyber Pakhtunkhwa Narcotic Control Wing (Reward) Rules, 2021.
 - (2) These rules shall come into force at once.
- 2. **Definitions.---**(1) Unless there is anything repugnant in the subject or context;
 - (a) "Act" means Khyber Pakhtunkhwa Control of Narcotic Substances Act, 2019 (Khyber Pakhtunkhwa Act No. XXXI of 2019);
 - (b) "commendable service" means an extraordinary service, rendered by the personnel or, as the case may be, the informer, by intercepting the transportation of narcotics substances, psychotropic, controlled substances or methamphetamine, for the purpose of seizure, recovery and investigation;
 - (c) "informer" means a member of public, giving tangible information, leading to the seizure or recovery of narcotic substances, psychotropic substances, controlled substances or methamphetamine;

- (d) "personnel" means the operational staff and investigation staff of the Narcotics Control Wing, involved in any form in the operations of interdiction or seizure of narcotic substances, psychotropic substances, controlled substances or methamphetamine; and
- (e) "reward" means complementary compensation to the personnel or informer for discharge of commendable services.
- (2) Words and expressions, used but not defined under these rules, shall have the same meanings as are assigned to them in the Act.
- Amounts of rewards.— Subject to rule 5, an amount of reward, as specified in Column No. 3 of the table below, shall be paid to the informer and personnel, in respect of seizure or recovery of narcotic substances, psychotropic substances, controlled substances or methamphetamine, as specified in column 2 thereof, namely:

| S.No. | Name of Narcotic Substance. | Reward. |
|-------|---|---|
| 1. | Methamphetamine. | Rupees Fifty thousand per kg. |
| 2. | Heroin. | Rupees Thirty thousand per kg. |
| 3. | Cocaine. | Rupees Thirty thousand per kg. |
| 4. | Hashish Oil. | Rupees Five thousand per liter. |
| 5. | Opium. | Rupees Three thousand per kg. |
| 6. | Chars or Hashish. | Rupees Three Thousand per kg. |
| 7. | Acetic anhydride. | Rupees Ten per liter. |
| 8. | Other narcotic substances or controlled substances. | Reward to be determined by the Director General depending upon the quantity and value of substances seized on case to case basis, which shall not exceed rupees five (05) lacs. |

4. **Distribution of amount of rewards.---**(1) The Director General shall, out of the amount of reward, admissible under rule 3, distribute it in the following manner:

| 1. | Informer. | One third of the admissible amount of reward, subject |

| 2. | Operational Staff of Narcotics Control Wing. | One third of the admissible amount of reward. |
| 3. | Investigation Staff of Narcotic Control Wing. | One third of the admissible amount of reward. |

Explanation: The amount of reward, so admissible to the informer at Serial No.1 of the table under sub-rule (1), shall not be payable to the personnel(s), in cases where seizure or recovery is made or effected by the personnel(s) on their own, without any role informer.

(2) 'The personnel, retired from service, and who had performed commendable services during his service, shall also be entitled to payment of reward after retirement these rules:

Provided that in case of death of the personnel, the widow or widower of such deceased personnel shall be eligible to receive reward, unless a contrary intention has been expressed, in writing, by the personnel, during his life time.

- 5. Payment to informer.—The Director General, on the recommendation of the Director, may pay half of the admissible amount, as specified in the table under rule 4 of these rules, to an informer upon seizure of narcotic substances, psychotropic, controlled substances or methamphetamine, while the remaining amount shall be paid on the completion of investigation.
- 6. Recommendation, etc. to be final.—Recommendation of Director, as to the identity of an informer or other matters connected therewith, shall, after approval of the Director General, be treated as final.
