No.2134/AC/117/Policy-VII. The Provincial Government are pleased to notify the following revised rules regarding enlistment of Contractors in the Food Department of the transportation of Foodstuffs and other ancillary matters:-

These rules will take immediate effect.

Classification.

1. There shall be the following three Classes of Contractors:-

Class	Unit for tenders			
A)	No limit			
B)	Upto Rs.10 lacs.			
C)	Upto Rs.05 lacs.			

2. The statement in respect of financial position shall be supported by Bank reference from scheduled Banks in Pakistan and by statement of moveable /immovable assets.

3. The contractor shall produce a certificate in the following form from the Income Tax Officer:-

4. Application for enrolment for all classes of contractors must be in a proper from which shall consist of parts (I). (II) and (III) as per enclosed sample forms. The application shall be submitted

through the Rationing Controller/District Food Controllers/Storage Enforcement Officers/Political Agents of the respective Districts/Agencies.

#### 5. **<u>REGISTRATION.</u>**

- 5.1 All the three classes of the contractor will be enlisted by a Committee, which shall consist of Director Food, Deputy Director Accounts, Assistant Director (Headquarter), Assistant Accounts Officer. After Enlistment the name of the contractor shall be circulated to all the Rationing Controller/District Food Controllers/Storage Enforcement Officers/Political Agents.
- 5.2 The Director Food shall be the Chairman of the Committee.
- 5.3 The decision regarding registration of the contractors shall be by majority of vote. The Chairman will also be eligible to vote. In case of a tie, the chairman shall have a second casting vote.
- 5.4 The quorum for the committee shall be two members.
- 5.5 The Assistant Accounts Officer shall act as Secretary to the Committee.
- 5.6 The Committee shall maintain a register of approved contractors and very contractor/Firm registered shall be allotted a registration number.
- 5.7 The Committee shall satisfy itself about the financial position of the contractor for undertaking the works in the class in which he is being registered, and his performance and experience in the past.

#### 6. **<u>REGISTRATION FEE.</u>**

- 6.1 To ensure the earnestness of a Contractor, he shall be directed at the time of enlistment to pay annual recurring fee as provided in Clause-6.3. the fee must be paid every financial year before the succeeding financial or the date fixed for the tender for the year whichever is earlier otherwise his name shall be struck off the approved list.
- 6.2 A certificate will be issued to the effect that annual fee has been paid by the contractor. This certificate shall be presented at the time of tender. The annual fee will be credited to C-03-Misc: Receipt, C-38-Others C-03841 fee, fines and forfeiter.
- 6.3 The registration /renewal fee of the Contractors shall be received directly by the Rationing Controller/District Food Controllers/Storage Enforcement Officers/Political Agents in whose jurisdiction he resides and normally carries on business. The amount of fee chargeable both at the time of registration and renewal shall be as under:-

#### 7. <u>TERMS AND CONDITIONS FOR REGISTRATION OF CARRIAGE</u> <u>CONTRACTORS OF EACH CLASS.</u>

- 7.1 The following shall be the terms and condition for the appointment of carriage contractor of each class.
  - I. Class "A".

- 7.2 A contractor must be a big transporters running his own goods transport or must have 8 trucks of his own. He shall produce their registration number in their own name or in the name of his firm proving that the firm is registered in his own name or in the name of co-sharer.
- 7.3 The contractor must have immoveable property worth not less than Rs.30 lacs.
- 7.4 The contractor shall produce bank balance certificate from any schedule bank of Pakistan worth not less than Rs.10 lacs.
- 7.5 The contractor must have experience of carriage work for about the three yeas as well as handling of foodgrains, etc.
- 7.6 The contractor must have his own employed labour at least above 20 to 30 persons and sufficient number weighing scale for Railway Stations and Godowns.
- 7.7 In case tender is accepted the contractor shall deposit cash security equal to 20% of the anticipated expenditure subject to the minimum of Rs.5 lacs.

#### II. Class "B".

- 7.8 A contractor must have his own Goods transport or must have 4 truck or 5 jeeps in case of Chitral District.
- 7.9 A contractor shall produce documents of immoveable property worth not less than Rs.20 lacs.
- 7.10 The contractor shall produce bank balance certificate from any scheduled bank of Pakistan worth not less than Rs.5 lacs.
- 7.11 The contractor must have about 10 to 20 labour employed by him and weighing scales.
- 7.12 The contractor must have experience of three years of carriage.
- 7.13 In case tender is accepted the contractor shall deposit cash security equal to 20% of the anticipated expenditure subject to the minimum of Rs.3 lacs.

#### III. Class "C".

- 7.14 The contractor must have at lest 2 trucks or three jeps in case of Chitral district.
- 7.15 The contractor shall produce documents of immoveable property of at least Rs.10 lacs.
- 7.16 The contractor shall produce Bank Balance Certificate worth not less than Rs.3 lacs.
- 7.17 The contractor must have experience of at least three years in carriage work as well as handling of Foodgrains.
- 7.18 The contractor must have his own employed labour of at least 5 to 10 persons.
- 7.19 In case of successful tender the contractor shall deposit cash security equal to 20% of the anticipated expenditure subject to minimum of Rs.2 lacs.
- 8. Tenders should be received from enlisted contractors only and entered in the tender register.

9. The approved contractors shall be required to provide bank gaurnatee or the satisfactory performance of the contract at the time of execution of contract agreement. If the contractor default the work carried out at his cost and risk and cost shall be recovered from the bank. The amount of bank guarantee shall not be less than 20% of the anticipated expenditure.
