## NOTIFICATION.

No. S.O.III(IND)48-21/73.--- In exercise of the powers conferred by clause (d) of subsection (2) of section 29 of the <sup>2</sup>[Khyber Pakhtunkhwa] <sup>3</sup>Sarhad Development Authority Act, 1972 (<sup>4</sup>[Khyber Pakhtunkhwa], Act No. XI of 1973), the Government of <sup>5</sup>[Khyber Pakhtunkhwa] are pleased to make the following rules, namely:---

- These rules may be called the  ${}^{6}$ [Khyber Pakhtunkhwa]  ${}^{7}$ Sarhad 1. Development Authority Loan Rules, 1975.
  - They shall come into force at once. (2)
- 2. In these rules, unless the context otherwise requires,---
  - "Authority" means the  ${}^8Sarhad$  Development Authority,  ${}^9[Khyber]$ (a) Pakhtunkhwa], established under section 3 of the <sup>10</sup>[Khyber Pakhtunkhwa] <sup>11</sup>Sarhad Development Authority Act, 1972 (<sup>12</sup>[Khyber Pakhtunkhwa] Act No. XI of 1973); and
  - "Government" means the Government of the <sup>13</sup>[Khyber Pakhtunkhwa]. (b)
- 3. "Subject to law and or instructions issued by Government, the Authority may with a view to financing its projects, draw at reasonable rate of interest, overdrafts or short term cash advances from financial institutions or banks"

- (2) "The Authority, may, with a view to financing various projects, raise funds in the form of long and medium term loans/debentures from public or financial institutions or banks".
- (3) "For the purpose of sub-rule (2), Government shall approve and specify the extent to which the long and medium term loans/debentures may be raised in respect of reach project".
