No. So-M(SWB) 4-1/2017. In exercise of the powers conferred by section 12 of the Khyber Pakhtunkhwa Senior Citizen Act, 2014 (Khyber Pakhtunkhwa Act No. XXXV of 2014), the Government of the Khyber Pakhtunkhwa is pleased to make the following rules, namely:-

THE KHYBER PAKHTUNKHWA SENIOR CITIZEN RULES, 2017

1. **Short title and commencement...**(1) These rules may be called the Khyber Pakhtunkhwa Senior Citizen Rules, 2017.

(2) They shall come into force at once.

2. **Definitions...** (1) In these rules, unless the context otherwise requires, the following expressions shall have the meanings hereby respectively assigned to them, that is to say,-

- (i) "Act" means the Khyber Pakhtunkhwa Senior Citizen Act, 2014 (Khyber Pakhtunkhwa Act No. XXXV of 2014);
- (ii) "member" means a member of the Council at clause (i) of sub-section (1) of section 4 of the Act;
- (iii) "Secretary" means the Secretary of the Council; and
- (iv) "Selection Committee" means the Selection Committee to be constituted for the recommendation of persons to be appointed as members at clause (i) of sub-section (1) of section 4 of the Act.

(2) Words and expression used but not defined in these rules shall have the same meanings as assigned to them in the Act.

3. **Selection Committee...**(1) The Selection Committee shall consist of the following: -

- (i) Chief Secretary Khyber Pakhtunkhwa or his nominee; Chairperson
- (ii) Secretary to Government Khyber Pakhtunkhwa, Health Department; Member

| (v) Director, Social Welfare | Member-cum-Secretary. |

(2) The Selection Committee shall scrutinize the documents and credentials of the candidates for the members as well as to ensure not to be convicted by any court of law for moral, civil or criminal turpitude.

4. Honoraria.... The members shall be entitled for honoraria for attending the meetings as Government may determine.

5. Procedure and criteria for senior citizen card... (1) A senior citizen may apply for senior citizen card.

(2) Each senior citizen shall have domicile of the Province.

(3) Each senior citizen shall submit a written application to the District Social Welfare Officer of the concerned District for provision of senior citizen card.

(4) On receipt of application, the concerned District Social Welfare Officer shall forward the same within three days to the Secretary.

(5) The Secretary after fulfillment of all codal formalities within one week shall issue the senior citizen card.
