GOVERNMENT OF ¹[Khyber Pakhtunkhwa] PROVINCIAL ZAKAT ADMINISTRATION.

NOTIFICATION.

No. 7156/Z&U/1(4)A-1.--- In exercise of the powers conferred by section 26 of the Zakat & Ushr Ordinance 1980 (XVIII of 1980), at the direction and the approval of the Central Zakat Council, the ²[Khyber Pakhtunkhwa] Zakat Council makes the following rules for review referred to in Section 21 (7) of the said Ordinance, namely:---

1. Short title, extent and commencement.---

(1) These rules may be called the Superceded and Removed Chairmen and Members of Zakat Committees (Application for Review) Rules, 1985.

- (2) They shall apply to the 3 [Khyber Pakhtunkhwa].
- (3) They shall come into force at once.

2. **Definitions**.---

In these rules, unless there is anything repugnant in the subject or context,

- (*i*) "Committee" means a District/Tehsil/Taluqa/Sub-Divisional or a Local Zakat Committee;
- (*ii*) "Council" means the Provincial Zakat Council;
- (*iii*) "Ordinance," means the Zakat & Ushr Ordinance, 1980 (XVIII of 1980).

3. **Filling of application for review.---**

The Chairman or a Member of a Committee, who has ceased to hold office under sub-section (1), or who has been removed under sub-section (3), of section 21 of the Ordinance may, within thirty days after the date of the resolution of the Council in this behalf, apply to the Council for a review of its decision.

4. Form and manner for filing an application for review.---

The application for review may be filed on plain paper addressed to the Council.

5. **Disposal of application for review.---**

(1) The Council shall consider the application in its 1st meeting held after receipt of the application and fix the date, time and place for giving personal hearing to the applicant and cause the applicant to be informed of such date, time and place.

(2) After considering the application for review and hearing the applicant, if he appears before it at the appointed time and place, the Council may take such decision on the application at it deems fit and pass resolution in terms of the decision and cause the decision to be communicated to the applicant within thirty days after the hearing.

(3) Where the Council decides the application in favour of the Chairman or Member, he shall be reinstated with effect from the date indicated in this behalf in the resolution.

6. **Explanation.---**

In these rules reference to the Provincial Council, shall, where the powers of the Council are exercised by the District Committee in pursuanace of sub-section (6) of section 21 of the Ordinance, be construed as reference to the 'District Committee'.
