No. S.O. (LG-III) LG-1/37/75.--- In exercise of the powers conferred by section 13 of the <sup>2</sup>[Khyber Pakhtunkhwa], Truck Stand and Traffic Control (Peshawar) Act, 1972 (<sup>3</sup>[Khyber Pakhtunkhwa] Act X of 1973) the Government of the <sup>4</sup>[Khyber Pakhtunkhwa], for the purpose of regulating the movement of truck within the limits of the Peshawar Municipal Corporation, is pleased to make the following rules, namely:---

**THE <sup>5</sup>[Khyber Pakhtunkhwa], TRUCK STAND AND TRAFFIC CONTROL  
(PESHAWAR) RULES, 1979**

1. *Short title and commencement.*--- (1) These rules may be called the <sup>6</sup>[Khyber Pakhtunkhwa], Truck Stand and Traffic Control (Peshawar) Rules, 1979.
2. They shall come into force at once.
2. *Definitions.*--- In these rules, unless the context otherwise requires, the following expressions shall have to meanings hereby respectively assigned to them, that is to say---
  - (a) “Corporation” means the Peshawar Municipal Corporation;
  - (b) “Corporation Limits” means the territorial limits of the Peshawar Municipal Corporation;
  - (c) “lessee” means the person or party to whom space is allotted under these rules, and includes a person to whom any shop, workshop, restaurant flat or any other building within the premises of the Truck Stand is left on hire;
  - (d) “truck” means any motor vehicle constructed or adapted for use for the carriage of goods, or any motor vehicle not so constructed or adapted

when used for the carriage of goods, solely or in additions to passengers;  
and

- (e) “Truck Stand” means the stand established by the Corporation on the Grand Truck Road near Surbilandpura at mile No. 3, or any other stand as may be established under these rules.

3. *Establishment, maintenance and administration of Truck Stand:-* (1) The corporation shall establish, maintain and administer such Truck Stands as may from time to time be required, and at such places as may be approved by the Commissioner.
- (2) The Truck Stand shall remain open for halting the Trucks round the clock, subject to the following conditions:
- (a) availability of space in the Truck Stand;
- (b) payment of fee as prescribed under these rules; and
- (c) no nuisance shall be caused by the truck driver, cleaner or any other person within the premises of the Truck Stand.
4. *Responsibility of damage to installations, etc.---* Any person who brings a truck into the Truck Stand shall be responsible for any damage to installations, fittings, fixtures or premises of the Truck Stand caused by his negligence, reckless driving or otherwise.
5. *Payment of fee.-* (1) Any person who halts a truck in the Truck Stand shall pay fee for such halting at the rate of rupee one per twenty-four hours or any part thereof.
- (2) The fee shall be payable by the Driver other person incharge of the Truck in advance when the truck enters the Truck Stand.
- (3) The Corporation may, lease out, by public auction, the collection of fee for a period not exceeding three years, on payment of such lease money and on such terms and conditions as may be determined.
6. *Prohibition on halting:---* For the purpose of loading and un-loading, a truck may halt at any place within the limits of the Corporation during the following hours:-
- (a) Winter ..... From 3 P.M. to 6.30 P.M
- (b) Summer..... From 4 P.M. to 5.00 A.M.
7. *Entry “Rehra” etc barred.---* No Rehra or cart not having pneumatic tyres shall be allowed to enter the truck stand.

8. *Grant of space on lease.* (1) The Corporation may lease out space within the premises of the Truck Stand to Goods Forwarding Agencies for the construction, at their own expense, of offices and godowns for such period as may be determined by the Commissioner, and payment of lease money at the rate of Rs. 5/ per 1000 Sft: P.M.
- (2) No agency to whom space has been allotted shall construct any structure as an office or godown except in accordance with the design and plan approved by the Corporation.
- (3) On the expiry of the lease, the proprietary rights over the building or structure shall vest in the Corporation on payment of such compensation to the lessee as may be mutually agreed upon or in the event of disagreement, as may be determined by an arbitrator to be appointed by mutual consent.
9. *Conditions of lease.*--- (1) No-lessee shall alter, construct or add to any building or structure in the truck stand without the prior approval of the Corporation.
- (2) No lesse shall sublet any building, space or part thereof allotted to him by the Corporation under these rules.
- (3) No building or space allotted to a lessee shall be used for any purpose other than the one for which it was allotted.
