The ¹[Khyber Pakhtunkhwa] Workers' Children (Education) [Disbursement of Benefits] Rules, 1975

No. S.O.E.P/17-11/74, dated 18th April, 1975: In exercise of the powers conferred by Section 6 of the Workers' Children (Education) Ordinance, 1972 (Ord. XI of 1972), the ²[Khyber Pakhtunkhwa] Government is pleased to make the following rules:--

1. (1) These rules may be called the ³[Khyber Pakhtunkhwa] Workers' Children (Education) (Disbursement of Benefits) Rules, 1975.

- (2) They shall come into force at once.
- 2. In these rules, unless the context otherwise requires,-
- (*a*) "beneficiary" means a child nominated by a worker in Part I of the Application Form appended to these rules and includes of child holding a School Leaving Certificate under rule 6;
- (b) "Director of Education" means the Director of Education, ⁴[Khyber Pakhtunkhwa];
- (c) "Form" means the Application Form appended to these rule;
- (*d*) "Government" means the Government of the ⁵[Khyber Pakhtunkhwa];
- (e) "Institution" means the Workers' Children (Education) Ordinance, 1972 (Ord. XI of 1972).

3. The type arid status of institutions where free education shall be imparted to the workers' children shall be as follows:--

(a) All Government schools and institutions, vocational, polytechnical and equivalent, catering for education needs of students from Class-I to Class X, and

(*b*) all schools or institutions, vocational, polytechnical and equivalent, recognised by Government, catering for education needs of students from Class-I to Class-X.

4. (1) Only one, child of each worker shall be entitled to the facilities of free education under these rules.

(2) A worker whose child is entitled to the facility of free education under these rules shall, in respect of each year for which the facility is claimed, fill in part I of the Form and submit it to the Head of the Institution where his Child is studying.

(3) If the contents of Part I of the Form are correct, the head of the Institution shall verify the same by filling in the relevant entries in Part II of the Form and forward the same to the employer or the manager of the establishment where the worker is employed.

(4) The employer or manager of the establishment concerned shall complete Part III of all such Forms received by him and forward them to the Director of Education by the first week of every month, alongwith a separate list of applicants in duplicate.

(5) The Director of Education, after necessary scrutiny and checking of the Form, shall arrange that payment in accordance with rule 5, in eligible cases, is made to the employers or managers of the establishments for disbursement to the workers concerned. The director of Education shall then fill in Part IV of the Form.

5. The beneficiary shall be allowed the following re-imbursement by the Director of Education:-

(i) The expenditure on books and stationery at the following rates:-

6. Where a beneficiary leaves an Institution for admission to any other Institution, the Head of the Institution concerned shall clearly indicate on the School Leaving Certificate of the beneficiary that he/she is a worker's son/daughter and is eligible for free education upto 10th class.

7. The Director of Education shall furnish an annual consolidated report to Government in September each year showing the amount disbursed to the Workers' Children under these rules.

8. The Director of Excise and Taxation, ⁶[Khyber Pakhtunkhwa] shall forward by 31st July each year to the Director of Education a list of establishments assessed to the cess under the Ordinance and regularly paying the same.
